1 Name

This determination is the *Designs (Approved Means for Paying a Fee) Determination 2019.*

2 Commencement

3 Authority

This determination is made under subsection 130A(1) of the Act.

4 Definitions

In this determination:

Act means the Designs Act 2003.

EFT means Electronic Funds Transfer.

EFTPOS means Electronic Funds Transfer at Point of Sale.

Part 2—Approved means for paying a fee

5 Approved means for paying a fee

For the purposes of subsection 130(2C) of the Act, the means for paying a fee are by:

- (a) credit card; or
- (b) accounts for selected services; or
- (c) cash, cheque or money order; or
- (d) EFTPOS; or
- (e) EFT; or
- (f) direct debit.

Note: The availability of payment methods may vary depending on the means of filing.

6 Preferred means for paying a fee

The preferred means for paying a fee are by:

- (a) credit card; or
- (b) direct debit.
